## CANDIDATE AFFIDAVIT INSTRUCTIONS

Colorado Revised Statute: CRS 1-45-103 (1.5) & CRS 1-45-110(1)

Who uses this form? All Candidates for public office including judges.

Purpose of form: This form is to be used by all candidates seeking an elected office.

Is this form required to be a candidate? YES

When do I file this form? Form must be filed with the appropriate election official within ten (10) days of becoming a candidate.

### COMPLETING THE FORM

1. Print or type your name (the candidate) on the first line.
2. Print or type the political affiliation of the candidate, only if seeking a partisan office (has a party identification on the ballot). Do not complete if you are a judge or municipal or special district candidate.
3. Print or type the office being sought.
4. Indicate the district number of the office being sought, if applicable.
5. Candidate must sign and date the form. **Signature must be notarized.**
6. Print or type the physical address of the committee.
7. Print or type the E-Mail address if you wish to have your E-Mail address public record. (optional)
8. Print or type your Web Site address if you wish to have your Web Site address public record. (optional)
9. **Notary Public to complete the remainder of the form.**
