2019 NOVEMBER MUNICIPAL FREQUENT AND ANNUAL
FILING CALENDAR**

If the municipal election isn't held on November 5, 2019, contact the municipal clerk for filing deadlines. Home Rule municipalities may have a different filing schedule; check with your municipal clerk to verify disclosure due dates.

Notes:

- Small-Scale Issue Committees (SSIC) are not required to file disclosure reports until they exceed \$5,000 in activity. After filing an initial disclosure report and converting to an Issue Committee, SSICs are subject to the disclosure requirements of 1-45-108(2), C.R.S.
- **24 Hour Notice of Major Contributor (MC) & 48 Hour Notice of Independent Expenditure (IE)** report periods start 30 days before the Biennial School Election and ends the day before the election. MC reports are due within 24 hours of receiving a qualifying contribution and IE reports are due within 48 hours of spending.

Frequent calendar applies to not yet terminated:

- Candidates or candidate committees whose office appears on the November 5, 2019 Coordinated Election ballot
- Issue committees whose issue attempts access to or appears on the November 5, 2019 Coordinated Election ballot

October

6 Starts the 30 day period before the Coordinated Election for 24 Hour MC rpts. & 48 Hour IE rpts. and concludes on November 4, 2019

15 21st day before the Election Report covers:

- October 28, 2018 through October 10, 2019

OR

- December 2, 2018 through October 10, 2019

November

1 Friday before the Election Report covers October 11, 2019 through October 27, 2019

5 Coordinated Election

December

5 Post-Election Report covers October 28, 2019 through November 30, 2019
