





# Colorado Ave - Business Type





Given the opportunity, would you utilize outdoor space to sell merchandise or serve patrons?





































If additional outdoor seating is available, how important is it for you to have alcohol service at your outdoor seating?



How important is it for your patrons to be able to take alcoholic beverages from your restaurant to outdoor seating provided either in front of your business or at communal locations along the street?






